
Survey Background

- Survey similar to 2013 Parent Survey with some minor additions, changes, deletions
- PASS39 & District 39 collaborated to develop the surveys
- Surveys were distributed in Spring 2015 by District39 via Survey Monkey
- Surveys were sent to parents of children with IEP's in District 39 being served by a District 39 school. One survey per family; families could fill out multiple times if they had more than one child with an IEP.
- Scale: Strongly Disagree, Disagree, Neutral, <u>Agree, Strongly</u>

The overall response rate was 22.0% (vs. 25.9% in 2013)





Satisfaction with transitions


"The district provides smooth transitions from year to year"*


Satisfaction with summer school decreased significantly

"The Extended School Year programming effectively supported my child's program"




Overall communication with staff ...

The IEP developed by my team meets my child's needs (85)


I am considered an equal member of my child's IEP team (89)

Percent Agree









Key concerns raised in the comments have changed...

2010

- Extended School Year programming is not effective
- IEP progress reports are hard to understand and not effective in communicating progress. Concerns that teachers are spending lots of time on charts that aren't very useful
- Inconsistency regarding communication with and effectiveness of district personnel

2013

- IEP progress reports are cumbersome and hard to understand
- Utilizing the Paraprofessional consistently to be an essential part of the IEP team
- Well –trained and effective teacher understanding Autism
- Homework management

2015

- Communication (while better with Google) is still inconsistent across team members
- Communication regarding staff changes was not proactive
- Summer Enrichment Program was not effective in maintaining goals
- IEP Progress Reports still lack meaningful information on student progress

Areas to research further

2013

- Streamlining the IEP reports to improve user-friendliness
- Continue to share "best practices" in making smooth transitions between buildings

2015

- Transition Process at all levels
- Summer Enrichment Program
- IEP Progress Reports
- Communication of changes in programs & staff at K-4, Highcrest, WJHS
- Consistent Communication to parents from ALL IEP team members
 - Class Teacher, Psychologists, Parapros,
 Coordinators
- Communication, Communication, Communication
